Gaston County

Mecklenburg County

Mecklenburg County Teen Court resumed hearings in September 2020 with a blended in person/virtual format in the Assistance League of Charlotte Board room to replace the unavailable courthouse setting. The result for this pandemic impacted year was that 178 youth offenders and volunteer teens provided 1,665 hours of community service. A total of 49 defendants successfully completed their cases with 16 cases currently active. In addition, Assistance League awarded six teen volunteers \$7,500 as Mecklenburg County Teen Court Recognition Scholarship recipients.

Wilson County

On Saturday, May 1st, 2021, Wilson County Teen Court participated in the inaugural MCEC Mock Trial Competition where they won 2nd place for overall county. Their prosecuting attorneys won 1st place best attorneys with a PERFECT SCORE! On Tuesday, June 1st, WCTC held their End of Year Celebration at Toisnot Park. Youth and Adult volunteers stopped by to have refreshments and receive awards for their work throughout the year
